Birth Certificate Format: The record consists of the name of the child, the year and month of birth, the day of birth, the name of the father or mother, the name of the father, the mother, the paternal and maternal grandparents, the county in which the birth occurred, the state in which the birth occurred, and the number of the record in the original. . All places must be numbered on the birth certificate, or the record will be invalid. . For example, in a given year the birth of a newborn could occur at the following hospitals: . FORM NO.. The original certificate and the certified copy must contain all the information as given in the application. . If the certified copy contains different information from that in the original, it must be returned to the county or municipality where the original was filed. Certificates must include the name of the child and of the applicant and the number of the record in the original. The county clerk may refuse to issue a certified copy without notice. . Certificates must not be altered in any way. A number of copies must be made of a certificate in order for a person to obtain one for himself or to enable someone to get a certified copy for himself or another person. If the number of the record in the original is not listed in the certificate, you must write the number in. . The fee is non-refundable. 5. The certificate is not available for any person born before the year 1924, except to the individual's attorney, the original county clerk, or an heir of the individual. . The original certificate must be kept in the office in which the application is filed for at least one year. All names on the certificate must be spelled correctly, and the number of the certificate in the original is the only number necessary. If it is important that the certificate be returned to the original number in the county or municipality where the original was filed, you must specify that number on the application. If you do not specify the number, the county clerk must return the certificate to the original number in the county or municipality where the original was filed. .
